Subject: Meeting with Championnat Rallye Québec Series Manager (Please note: Any and all information exchanged during this meeting is to remain confidential and may not be used in any other litigation should that situation arise)

Your presence is requested at a meeting with Mr. Éric Tremblay, Championnat Rallye Québec Series Manager (Promoter) concerning the following points:

- The requirement for the Promoter to terminate the 3-year agreement with Pirelli in order to obtain the CARS permit to hold the Rallye Ville La Tuque (Ref: Doc 1);
- The requirement for the Promoter to terminate the new 3-year agreement (2017, 2018, and 2019) with Panta in order to obtain the CARS permit to hold the Rallye Ville La Tuque (Ref: Doc 1);
- The running of the Rallye de Charlevoix 2016 as a regional stand alone event that does not form part of the Championnat Rallye Québec calendar. See Article 3.e Obligations of the RSQ to the CRQ (Ref: Doc 2);
- The proposition put forward to the CARS council aiming to ban the Promoter from administering, promoting or organizing rally events after December 31, 2016. (Ref. Doc 3).

The meeting will take place in Montréal and you may choose one of the three following dates and times:

- · March 14, day time or night time;
- March 15, day time;
- March 16, day time.

Your confirmation is requested by Tuesday, March 10th at 12:00 PM or sooner.

The group discussed the current CRQ situation and request at length and decided that it would be best for Max to respond and indicate that Patrick Rainville the RSQ Vice President would attend the meeting with him. The meeting should be held without prejudice, with only the invited participants and in accordance with the preset agenda.

Patrick did a good job of explaining the ongoing relationship between RSQ and CRQ and that Eric has and continues to flaunt the rules. The most recent example was the last minute request for approval of the WRC studs for Rally Ville Le Tuque. That was received days before the event after contractual commitments had been made and competitors had already purchased the studded tires.

Board members got a good sense that Patrick has a clear view of the issues and is able to explain them well.

Patrick explained that meeting Eric and the four sponsors would provide a good opportunity for CARS and RSQ to explain how the CRQ has deviated from the rules and did not have approval to do much of what is has done.

All agreed that neither CARS nor RSQ would re-sign the contract with CRQ after it expires in 2016. The intent is that any regional championship in Quebec would be run by RSQ in compliance with CARS sanction rules, as is the case in the rest of the country.

The group discussed the reason Max asked Eric to change the sponsorship contract end dates to align with the end of his contract as the promoter. By doing this now it is clear that after the 2016 season Eric will not have a contract with RSQ & CARS. However if Eric wants to maintain his sponsorship contracts under these circumstances, CARS really has no objection. It is more a case of CARS and RSQ making sure that everyone understands Eric's ability to commit after the 2016 season.

The proposal made to ban Eric from future rally had been discussed at an earlier board meeting, at that time the board had not accepted the proposal. However we had not documented a formal vote, so tonight a formal motion was made to decline the request to ban Eric. The motion was seconded. The vote supported the motion. CARS does not intend to implement the proposal to ban Eric.

In further discussion on the topic the board recognizes a lot of good work that Eric does as an organizer of regional rallies and the group felt that we should encourage Eric to continue running the events and apply for regional status and to be part of the Quebec Regional Championship in 2017 and beyond and work within the system of amateur rally in Canada.

Max drafted his response to Eric's request as per the meeting.

Hello Mr. Tremblay,

I agree to meet you as well as the sponsors of the rally of the Quebec Championship. The chosen date is March 14 in the afternoon and evening.

I'll be there to represent CARS and will be accompanied by Patrick Rainville as representative of Rally Sport Québec.
